# Letter From the President

It is hard to believe, that in just one more month we will have our PAA pow-wow in Buffalo NY. At last report, Don Halseth told us registration is moving along. Early registration ends July 15, 2008 so get your registration in and reserve your room now. I also understand that Larry Hiller is going broke from matching all those contributions to Henry De Jong's bike ride: keep those pledges coming! Don't forget to check the PAA08 website (<a href="http://www.hort.cornell.edu/paa2008/index.htm">http://www.hort.cornell.edu/paa2008/index.htm</a>) for the complete program and other information about the meeting.

Since the last PAA *Insider*, the Executive Committee (EC) has met twice via teleconference. The last meeting was in June. These teleconferences should help the EC meetings run more effectively and efficiently at the PAA meeting.

#### **Updates:**

- 1. Loretta Mikitzel reported that the PAA08 received 103 abstracts for our meeting; these include 16 poster and 87 oral presentations. The program includes an Industry Session (Applied Production and Management Session) and a Genomics Session. There are 9 submissions for the Graduate Student Competition.
- 2. Al Bushway reported that our financial matters with the IRS have all been taken care of and all penalties have been waived.
- 3. Changes to our Constitution and Bylaws are being voted on by the EC and will be presented at the Business meeting. The changes deal mostly with Springer and concern the group membership category, electronic *AJPR* copies and Technical Editor position. Other changes involve delineating duties of EC officers such as Past President

and Directors, and clarifying the evaluation process of the Administrative Assistant. Lastly, a key change is to alter our budget from a fiscal year to a calendar year.

- 4. With a generous donation from LAC07, the Speakers Fund is solvent and can help cover Symposium expenses for 2008.
- 5. The transition of *AJPR* to Springer is now complete and the issue publication schedule should be back on track soon.
- 6. The website is ready for testing and should be functioning by the end of this summer. PAA Sections need to have their material ready for posting at that time.
- 7. AJ Bussan is heading up the Extension Section committee working on a proposed Extension Award and its guidelines. If all goes well, the award may get instituted for PAA09.
- 8. Past President Sam Thornton will be the new Chair of the Finance Committee.
- 9. Chuck Brown will be representing PAA at the EAPR meetings in Brasov, Romania July 6-10, 2008.
- 10. Leigh Morrow and I are still busy working with the National Potato Council on the proposed Sustainable Agricultural Standards for potato.

#### Constitution & Bylaws of The Potato Association of America "Constitution"

AREAS TO BE CHANGED [DELETED/ADDED] WILL BE IN BRACKETS [] AND WHAT THEY ARE CURRENTLY WILL BE IN '...'

#### CONSTITUTION

Article IX. Publication, Section 4. change 'Technical Editor' to [Editor-in-Chief]

Section 4. The Executive Committee may authorize the 'Technical Editor' [ Editor-in-Chief ] and other officers to employ such assistants as may be necessary for the proper conduct of their work

Article X. Funds, Section 1. change 'each' to [every other]

Section 1. Control of the funds of The Association, received from any source, shall be vested in the Executive Committee to be administered through the Treasurer. An audit of the receipts and disbursements shall be made at the end of 'each' [ every other ] fiscal year by a certified public accountant. The reports of the Treasurer, or other fiscal officers, shall be published annually in the PAA Insider.

The Editorial Board shall have authority to accept any manuscript deemed worthy of publication.

## Members in the News

Since the publishing of the last PAA Insider newsletter, the PAA has lost another Honorary Life Member J. R. "Jack" Simplot passed away on May 25th at the age of 99 at his home in Boise, Idaho.

At an early age J.R. Simplot move to Idaho with his parents where he remained for the rest of his life. He spent his youth on a farm in southern Idaho and while still in his teens began growing, packing and shipping potatoes. J.R. left home in 1923 at age 14 with four gold coins given to him by his mother and from this small beginning, a major industrial complex has since grown. As his life has ended, it is as the spud king of America. The Idaho farmer dominated the state's business and political landscape for 70 years. His businesses, still family owned, manufacture agriculture, horticulture and turf fertilizers; animal feed and seeds; food products such as fruits, potatoes and other vegetables; and industrial chemicals and irrigation products. He all but invented the first commercially viable frozen french fries in the world.

When Robert Mercer nominated him for the PAA HLM award, he used quotes from those who had known him best from his past: "I don't believe

anyone could be more thoroughly enthused about the Idaho potato industry than Jack Simplot." "From the very beginning he saw and envisioned the future of the Idaho potato industry. He thoroughly believed in the Idaho potato." "He always did the right thing." "A staunch supporter of every aspect of the potato industry."

I guess the best word to describe Mr. Jack Simplot and his success is enthusiasm. He was always enthused and optimistic and sang the praises of the Idaho potato. ~Robert Mercer!

Larry K Hiller retired from Washington State University at the end of 2007 after 35 years of teaching and research in vegetable crops and potatoes.

His wife Jan also retired January 2008 with over 30 years of 4-H youth development and volunteer management programs. Larry says that they plan to do the usual retirement stuff = garden, travel extensively (especially with his 94-year-old father), walk and exercise, and pursue family genealogy. He expects to stay involved with PAA as well.
