

IRISH POTATOES
Utilization of 1968 Crop with Comparisons

Potatoes sold for table stock from the 1968 crop totaled 125.3 million hundredweight, 4 percent less than the 131.2 million a year earlier and 6 percent less than from the 1966 crop, according to the Crop Reporting Board. The quantity processed for food products (excluding starch and flour) from the 1968 crop was 105.5 million cwt., 12 percent more than a year earlier and 10 percent above the 1966 crop. Quantities sold for starch, flour and livestock feed totaled 16.2 million cwt., a decline of 12.7 million from the 1967 crop when potatoes were diverted under the USDA diversion program for starch, livestock feed and freeze-dried.

Household use of potatoes for food on farms where grown continued to decline. The 2.1 million cwt. used from the 1968 crop compares with 2.3 million a year earlier. The quantity fed to livestock on farms where grown was 25 percent less than a year earlier. The quantity used for seed on farms where grown totaled 6.9 million from the 1968 crop, which compares with 7.4 million cwt. from the 1967 crop. Shrinkage and loss totaled 18.9 million cwt. for the 1968 crop, down from the 22.5 million for 1967.

Total sales accounted for 264.2 million cwt. from the 1968 crop, and 270.3 million cwt. were sold a year earlier.

Quantities used in the processing of frozen french fries accounted for 37.8 million cwt. from the 1968 crop, compared with 34.6 million a year earlier. Other frozen products used 6.8 million cwt. from the 1968 crop compared with 5.0 million for the 1967 crop.

Potatoes used for chips and shoestrings totaled 34.1 million cwt. from the 1968 crop, 5 percent above the quantity used from the 1967 crop. On a fiscal year basis (July 1, 1968 through June 30, 1969), the quantity used for chips and shoestrings was 34.3 million cwt., compared with the 33.0 million used a year earlier, and 32.8 million cwt. for the year ended June 30, 1967.
